Chair David McCluskey called the meeting to order at 6:31 pm. A flag salute was conducted and a moment of silence was observed.

Superintendent's Report:

At the last Board Meeting we talked about the calendar for the next school year and having some flexibility in the last early release day based on snow days. Susan Smith has spoken with the Administrative Team and the Teachers' Association about this year's school calendar. We would move our last early release day in the 3rd trimester for this year from Friday, June 2 to Friday, June 9. The Board members were in agreement. Susan Smith will send out a community message to let people know about the change in our last early release day, the students' last day, teachers' last day and the school calendar for next year.

Susan Smith distributed some information on the Supreme Court ruling in Special Education. School districts are already crafting IEPs that enable a child to make progress in light of the child's circumstances. Jesse Gauthier did attend some training from Drummond and

Woodsum, which was applicable to this in guiding our special education teachers and case managers in the IEP process.

We have a bus for sale. We have received some phone calls on the bus but no bids.

We have purchased a van through the State auction for \$1,400. The van will need some repairs, which should cost less than \$600, staying below the allotted total of \$2,000.

Susan Smith distributed two pictures in relation to issues we have had at the Holbrook School. The boiler leaked and we had to replace the seams, as well as some gaskets and gauges. The beam out front has rotted away. It would cost approximately \$1,600 to shorten the overhang or \$1,800 to replace the beam so overhang stays the same.

RSU 63's Chair Report:

David McCluskey reviewed the superintendent review process for the Board members and will be sending the Board members materials to complete and return in confidence at the April Board Meeting.

- 2) **Traffic/Safety Issues** – There have been concerns since the beginning of the school year with traffic on all three roads – Route 1A, Route 9 and Kidder Hill Road. During sports season, we have a lot more parent pickups at the Holbrook School with the line of cars going out on to the Kidder Hill Road. The Holden police have been helpful trying to get more staff out by the Holden and Holbrook Schools in the morning and afternoon. Some parents feel the flashing lights at the Holden School should be on for a longer period of time, while others feel it should be for a shorter period of time. George Cummings is training staff tomorrow on how to reset the flashing lights at Holden School. Jenn Newcomb noted that the Holden Town has budgeted for another full-time police officer in next year's town budget, which will hopefully afford them to put a presence more regularly at the Holden School. The Board members discussed different options for flashing lights/signs at each of the schools. Susan Smith to investigate re-positioning/moving the sign coming from Brewer to Holden School and making it bigger and more noticeable, and changing the numbers showing the times/hours on the Eddington sign. The Board members discussed installing flashing signs outside Holbrook School. If we wanted flashing signs, we would have to pay for them. D.O.T. does not cover that cost. Susan Smith to contact D.O.T. to have one of their representatives visit our schools.
