Recognition and/or Awards of Students. Staff. and Others: Superintendent Smith advised the Best Buddies Program was nominated for the National School Boards Association (NSBA) Magna Award. Jayden Schoppee placed third out of 4,000 students in the middle school division of the "What Freedom Means to Me After Interviewing a Veteran" essay contest.

Acceptance of Gifts/Donations: RSU 63 was awarded \$500 for computer science education planning from Educate ME and Project Login.

Presentation: Superintendent Smith introduced George Cummings, Technology Director. Mr. Cummings reviewed a handout that detailed all devices, software, and servers: including age, location, quantity, and how the device(s) were acquired (i.e. lease or donation). Mr. Cummings highlighted devices that will need replacement or updating.

<u>Questions and Comments from the Board:</u> Gavin Robinson asked if the aging devices and software posed any security risks. Mr. Cummings advised the software will become obsolete before it becomes a security threat. It also becomes difficult to obtain replacement parts. Charles Baker asked about the cost was to replace/update the servers as they enter their end-of-life stages. Mr. Cummings advised \$3,000 to \$3,500.

Superintendent's Report: Superintendent Smith advised the Board that she and Jake Morgan, Transportation and Facilities Director met with Ed Daly of Energy Systems Group (ESG). He would like the opportunity to meet with the Board to express apologies for events that took place.

Superintendent Smith and Holly Whitmore planned to attend a grant writing class through the Maine Community Foundation. Due to weather, the class was rescheduled to December 10th. Ms. Smith is unable to attend however Ms. Whitmore will be attending on the behalf of them both.

Education Week is a research-based journal that did an article called "What School Shooters Have in Common." The Secret Service also sent out information saying there is no profile for a school shooter. School Security is an industry and some security upgrades are an overreaction. No research has proven or shown that adding security devices to schools are making a difference. Lockdowns are sometimes backfiring and showing the school shooter how these types of events are handled and showing younger students this is normal, when in fact it is not.

Old Business:

Facilities Advisory Committee Update – Recommendations for FY21 Budget: Charles Baker reviewed the priority lists for each school. His recommendation on behalf of the Facilities Advisory Committee is a bond for \$2.3 million with payment over a 15-year span. This would address the larger problems and projects completions would occur over the next three years. The second option would be \$350,000 in FY21 budget to address some of the immediate needs. Superintendent Smith advised the approved Revolving Fund Grant applicants will be notified February 1st. Mr. Baker suggested reaching out to the University of Maine Engineering program. Holly Whitmore reached out to them and there is possible interest in helping RSU 63 with some engineering projects (i.e.: traffic study, parking, etc.).
