- 2. FY20 Financials (May)
 - a. Summary & General Fund:
 - **a.** The report includes encumbrances for big purchases like the bus, roof, fence, flashing lights, etc.
 - **b.** District projects will be \$820,000 under budget even with these expenses.
 - c. Gavin asked about operating under existing budget and what that means for pay increases and managing expenses. Susan responded that the State has given us flexibility in the budget to still allow pay increases even though we are operating under the structure of the FY20 budget.
 - **d.** We discussed the Governors new budget process to ensure we are working within the proper framework for dates and meeting styles.

b. Hot Lunch

a. Will finish with a small balance forward. The District will continue to provide food until the end of June.

c. Activities Summary

a. Reported on all accounts with balances rolling more than \$2,000 forward. PTG provided a summary of activities. Discussed Eddington Teachers separate 501c3 and account not overseen by the District. Discussed funds from DI for elementary computer science.

3. Fountas & Pinnell

a. This reading program will work well with remote learning. The digital codes have been one aspect working well getting access to reading materials.

b. Committee recommends purchase to Board.

4. Facilities

- **a.** PO for roof work and flashing lights with concreate pad at Eddington have been created.
- **b.** Oil tank has been removed at Holden.
- c. Discussed bonds. Decided we will limit request to only the SRRF bond (forego at this time the additional local only bond of approx. 5 million) given the current economic uncertainty affecting our Towns. SRRF will assist indoor air quality, which will be a factor going forward post-COVID.

5. Transportation

- **b.** Annual Written Reasonable Assurance has been provided to all hourly staff. This notification informs staff that we intend to hold their employment in the fall and prohibits them from collecting unemployment through RSU63.

RSU 63 Fiscal Year 2021 Budget (Draft 5) Summary For 2020-2021 School Year

CHANGES IN REVENUE

The Proposed RSU 63 Budget for FY21 is an increase of \$125,927.63 (1.2%) over the 2019-20 Budget and a total of \$11,040,755.05. State funding to RSU 63 will increase by \$130,499.60. Local assessments to towns will decrease by (\$10,112.97).

- Clifton decrease (\$2,458.21) -0.3%
- Eddington decrease (\$10,598.42) -0.6%
- Holden increase \$2,943.66 +0.1% (due to increase in State's evaluation of Holden property)

CHANGES IN EXPENDITURES

System Administration, School Administration, Regular Instruction PreK-Grade 8, High School Tuition, Special Education, Staff & Student Support, Other Instruction, and Transportation: Decrease by a total of (\$54,832).

Changes include:

- Expanding the Holbrook Middle School STEM (Science, Technology, Engineering, and Math) position to include Computer Science and Technology instruction for all students Pre-Kindergarten through Grade 8.
- Decreasing the Holbrook Middle School Music position to 4 days per week while maintaining music, band, and chorus.
- Formalizing a 1 day per week Gifted and Talented Coordinator Position for the district.
- Using a combination of grant and local funds to have a full-time Librarian and a parttime Library Educational Technician in order to provide Library/Media instruction for all students in Pre-Kindergarten through Grade 8.
- Starting a Life Skills program at the Eddington School for young students with developmental delays.

Facilities:

This FY21 Budget includes an increase of \$180,760 for facilities (anticipating \$150,000 for a generator at Holden and \$54,000 for carpet/tile replacement and asbestos abatement in four classrooms at Holbrook).


- Our aging school buildings have benefited from \$200,000 (through a 5-year bond) to repair roofs (Holbrook and Eddington), replace some heat controls (Holbrook), and replace two cracked sections of boilers (Holden).
- Working with Carpenter Associates of Old Town, extensive assessments of all three schools were conducted and priorities identified.
- Funding from the State (approximately \$1.3M) is available to improve the indoor air quality at all three schools. A referendum vote in November is needed to receive these matching funds and an interest-free loan.







ARTICLE 12 Shall Regional School Unit No. 63 raise and appropriate \$1,475,863.27 in additional local funds, which exceeds the State's Essential Programs and Services allocation model by \$1,475,863.27 as required to fund the budget recommended by the Board of Directors? The Board of Directors recommends \$1,475,863.27 for additional local funds and gives the following reason(s) for exceeding the State's Essential Programs and Services funding model by \$1,475,863.27. The District's Facilities, Transportation and Special Education costs are higher than allocated by the model and actual secondary tuition costs are higher than funded through the EPS model. Additionally, the District's educational staffing ratios slightly exceed the staffing ratios recommended by the State's Essential Programs and Services funding model and System Administration is only partially funded in the current formula.

- ARTICLE 14 To see what sum the District will appropriate \$3,619.28 for Adult Education and raise \$3,619.28 as the local share; with authorization to expend any additional, incidental, or miscellaneous receipts in the interest and for the well-being of the adult education program.
- ARTICLE 15 Shall the regional vocational operating budget as approved by the cooperative board for the year beginning July 1, 2020 and ending June 30, 2021 be approved in the amount of \$3,105,184.26?

COVID-19

As we end this school year, many people are speculating about the start of the 2020-2021 school year. While the Maine Department for Education (DOE) and Maine CDC are working on developing clear and specific guidance, we are beginning to plan for a range of possibilities such as in-class learning with social distancing, a hybrid of remote and in-class learning, and all remote learning. Our collective knowledge and understanding of COVID 19 is changing rapidly. Additional information and updates over the next three months will impact our decisions.

Our teachers and administrators will continue to discuss what worked with remote learning this spring and what needs to be improved if we continue with distance learning; even if remote learning is needed just for "snow days." We know specific assignments and due dates, given in common formats and collected in similar ways across the district would help parents and students. We know all our students need computers (or tablets) and good connection to the internet. Having common equipment, common educational software, and clear expectations will be helpful.

We would also like to hear from our parents and will be sending out a brief survey for them to give us feedback regarding their experiences with remote learning this spring. Parents and students will continue to be invited to provide feedback and input into plans for next year through surveys, email, and/or video conferencing. We will do our very best to create detailed plans, knowing we may need to shift between them as the situations and knowledge changes.

Recognitions

We look forward to welcoming a new member to the RSU 63 Board of Directors after Holden's election on June 9th. We will be acknowledging our Grade 8 students who earned awards and recognizing Mr. Modery as he leaves Holbrook Middle School to become the Superintendent in Glenburn.

Presentation and Public Hearing

While the timing is different this year, we are following the steps we traditionally use to explain our proposed budget for next year and have it voted on by our residents. The presentation will follow the "Proposed FY 21 Budget Overview" documents and provide an opportunity for members of the public to ask questions.

Fountas and Pinnell Instructional Materials for Reading

It has been approximately 13 years since RSU 63 has purchased resources for teaching reading. The standards and expectations have changed significantly, but our instructional materials have not. I am pleased with the progress made this school year analyzing our data and updating our reading priorities as well as researching and selecting instructional materials. During the Board Meeting held on May 11, 2020 the RSU 63 Board of Directors approved Fountas & Pinnell Classroom materials for reading instruction. (See attached for additional information about these materials.)

In April, \$47,714 was cut from Draft 4 of the 2020-2021 Budget with the intent to purchase Fountas and Pinnell materials for reading instruction using funds from this current school year. As we reach the end of this budget year, we project to have a balance forward of approximately \$820,000. We have used grant funds (thanks to Cole Family Foundation, Small Rural Schools, and Well-Rounded Education grants) to purchase the Grade 1 Guided Reading Collection and the Book Club Collection for Holbrook. It is my recommendation that we use \$3,000 from the Small Rural Schools grant and approximately \$37,250 from our "Regular Instruction" Cost Center to purchase the remaining materials for PK, K, and Grades 2 – 6. Making this purchase now will allow our teachers digital access to all the materials so they can familiarize themselves this summer and be ready to go in the fall.






