This group is overseen by Joy Walters, Hillari Morgan, and Amy Clement. Our Pre-Kindergarten Teacher, Sarah Gooding, facilitated a PREP (Penobscot River Educational Partnership) workshop on Social Emotional Learning for young children.

Acceptance of Gifts/Donations:

Roxanne Dubay delivered "Tobacco Free Campus" signs for all three schools to the Central Office on March 16, 2018. Holbrook Middle School received an anonymous donation of winter hats and mittens. Sam Bedore's Fourth Grade Class received \$177.29 from Donors Choose for writing supplies and materials. They are working on opinion writing, with a theme of "Opinions are like noses, we all have them".

Presentations:

Superintendent Susan Smith shared the comparative RSU #63, State, and surrounding District MEA (Maine Educational Assessment) data with the Board. RSU #63 is above State MEA averages in Math, ELA (English Language Arts), and Science. We are within the same range as surrounding school districts for all three subjects.

Superintendent Smith, Richard Modery, Don Spencer, and Jesse Gauthier discussed Academic Programming with the Board. They reviewed what is going well, plans for next year, and long-term goals.

Cost Benefit Analysis: Discussion included the possibility of changing the focus of the Oak Point proposal to include two options rather than five options. The town leaders who were present at the last New School Community Committee made it clear they are not interested in building a new school with only local funds. They would be more interested in paying Oak Point to conduct the study after we receive the State List and know where the District stands with State funding.
